Grievances

The Grievance Team continues to present a number of individual Grievances (in addition to class actions that have been filed) regarding observations, student growth measures, and teacher effectiveness ratings. The Grievance Team also spent time in arbitration this week, continuing to fight for members who wrongly disciplined.

SIG Schools

Mark Baumgartner wants everyone to know that there have been 8 SIG schools identified for the 2014-2015 school year. They are: Adlai Stevenson, Alfred Benesch, Bolton, Case, Collinwood, Fullerton, Patrick Henry, and Robert Jamison.

To that end, the district has set up two days of meetings (August 4 & August 5) with state support personnel. Teachers who attend will be compensated at the \$41.16/hour rate.

The meetings are not mandatory for teachers to attend.

Principals may have emailed their staff saying they are mandatory meetings, but they are not.

The meetings are mandatory for the principals and that mandatory notice may have been misunderstood by the principals.

AGAIN, the following dates (August 4 & August 5) are voluntary for teachers, but if teachers attend they will be compensated at \$41.16 an hour.

- * This is a group of 4 or 5 teachers.
- * You and your principal should decide who is the best fit from your AAP, APT, and UCC.

Tuesday, August 5. 8:30 am-3:00 pm @ Cleveland Hilton East Beachwood

- * The entire teaching staff of the school is invited.
- * This is not mandatory but the entire teaching staff is invited.

License Renewal

Everyone that has a license that expires in 2014 should have already applied and paid for license online and submitted appropriate paperwork to CMSD. The average wait time to have license approved in CMSD (according to ODE site) is 16 days. We know some have been far more due to technical issues with the new system and the huge influx of applications in May and June. If you have completed your application and payment with the ODE and you are still waiting for approval, please check your CMSD and personal emails for an email from ODE or CMSD to see what the issue is. All licenses with applications, payments, and complete materials submitted to the district have been approved as of July 29. Anyone who has applied and not been approved should have received an email from ODE or CMSD. You can also email Tracy Radich who is working with the District to facilitate the process.

46th Annual Hispanic Parade

Common Core Legislation

House Republicans announced Monday they will take up legislation to scrap the Common Core academic content standards and related tests, with plans to have the measure passed out of committee in August. Speaker Pro Tempore Rep. Matt Huffman (R-Lima) and Rep. Andy Thompson (R-Marietta) introduced the placeholder bill (HB 597), which would eliminate the standards and tests and replace them with something different that has been proven effective elsewhere in the country. It will be heard in the Rules Committee twice per week starting Aug. 12. House Speaker Bill Batchelder (R-Medina) has indicated the bill would not come to the floor until November.

In July the CTU Executive Board passed a Motion to call for a Pause to administering PARCC assessments and using the results for high stakes decision making for both students and educators until it is ensured that districts are prepared (as educators, students, and with technology infrastructure), the tests are proven valid, and the tests are fair for all groups of students (urban, rural, suburban, special needs, ELL, etc.). The Executive Board would work with Ohio legislators to have a bill introduced and form a coalition with other OFT locals, independent, and NEA locals to influence the legislation and convince legislators of the need to put brakes on the stakes. This move by the Republicans is interesting (with a vote not coming until after the November elections). CTU is working with local legislators, our lobbyist, and our partners to see what is the best way to proceed. We need to make sure that the right things happen for our teachers, paraprofessionals, related service providers, and our students. We will keep you posted.

Differentiated Compensation

All members who were on the Cleveland Differentiated Compensation System (CDCS) during the 2013-14 school year can now verify their current Achievement Credit (AC) totals, as well as other awards they are due through CDCS.
