ELECTION DAY

Election Day is only 8 days away. Kurt Richards wants to make sure that everyone has a voting plan. Are you going to the polls on Election Day or did you request an absentee ballot? If you have an absentee ballot, have you voted and mailed it back yet? Besides the important pro-labor candidates that need to be elected, Issue 4 the school Bond Issue is also on the ballot. Passage of Issue 4 will enable 20-22 new schools to be built, 23 more to be revamped, and create a maintenance fund. All of this without raising taxes - and don't forget that 2/3 is paid for by the state.

Phone banks will be closed on October 30 (first home Cavs game) and October 31. There are still plenty of other times that are available.

TEACHER EFFECTIVENESS RATING

The Grievance Team wants to remind everyone again that if you are planning on grieving your Teacher

Effectiveness Rating for the 2013-14 school year you have 60 working days from your first day of work this school year. For most of us the deadline is November 4, 2014. If your school year started prior to August 11, 2014, count how many days you worked before August 11th and your 60 day deadline is that same number of days before November 4th.

SPECIAL EDUCATION COUNT

The count that determined special education funding used to be on December 1, 2014. This year it has been moved up to October 31, 2014. This is why many of our members are being pressured to complete all ALERTS (IEPs for students who transferred in from other districts) and any IEPs due during October. There needs to be time given for our members to get this important work completed. Please work with your administrators and APT to ensure that time is allotted.

OPEN ENROLLMENT

Michael Kulcsar wants everyone to be aware that November is Open Enrollment Month for healthcare. This is the one month of the year that you can change your health insurance, amend dental, add an FSA, etc. Nothing has changed in any of the plans since the contract was ratified in 2013. If you are happy with your coverage as it is – you do not need to do anything. However, it is always recommended by the CTU that you check and make sure that all of the information is correct and that you have the coverage that you signed up for. The dates for Open Enrollment have changed slightly – the Open Enrollment period will be from Monday, November 3 through Tuesday, November 2. This was done so that the open enrollment period would not begin and end on a weekend.

There are 2 information sessions for anyone that is interested in learning more about the plans. The first is on Wednesday, October 29 and is geared for employees new to the district and Wednesday, November 12 which is geared for all employees. These sessions will be held at East Professional Development Center (1349 East 79th Street) in the Media Center from 5:15-6:15.

TDES MESSAGE VIA EMAIL

TDES Committee wants to make sure that everyone saw the joint email of what to do – if you have not had your first walk-through by the due date. Here is some of that message:

If your evaluator has not completed your observation event by the deadline, you need to *email your evaluator* noting your concern about your missing observation.

For example, "Dear Mr. Principal, The deadline for Walkthrough 1 is tomorrow and I have not yet had my Walkthrough 1. I am sending you this notice in accordance with the CBA Article 13, Section I and look forward to my observation. Sincerely, Mrs. Teacher"

You can also Cc TDES@clevelandmetroschools.org on your email to the evaluator, and should email the TDES mailbox if the lack of observation continues. The email will be kept in the TDES mailbox and a copy will be sent to the co-chairs of the TDES Steering Committee (Christine Fowler-Mack and Jillian Ahrens). You do not need to email the co-chairs individually if you use the TDES mailbox. They will be able to read your email and a copy will be kept for future reference if necessary. This is the best way to document your lack of

observation: 1. Email the evaluator 2. Cc the TDES mailbox.

TDES FORMAL ANNOUNCED

Administrators are beginning to conduct formal announced observations. Remember, after your conference you have the opportunity to review what was submitted and add additional evidence to create a richer and fuller record of the lesson. Adding evidence that reflects the whole picture is important. If after your post conference – there is a discrepancy a teacher has the right to request intervention and/or support from the Academic Superintendent within 10 working days.
