## PAUSE ON PARCC

A message from David regarding testing and using PARCC for high stakes decisions: There is way too much testing. The CTU is opposed to the entire over testing of our students. Some of these tests are required by the District, some are state mandated, some are a result of 3rd grade guarantee law, some are needed for SLOs. It is just too much. Tracy Radich, Shari Obrenski, Mary Moore, and I have all been to Columbus talking to law makers and ODE about the over testing, the impact on students, and the classroom. There are many Ohio law makers who want to figure out a way to reduce testing. Republican and Democrats agree the kids are over-tested and it is getting worse with the introduction of PARCC. I think that this is going to be a priority for legislators this legislative session. Believe me; we are all working on this.

What the CTU does not want to get lost in the mix is the fact that the regardless of if and when the Ohio General Assembly acts on the over-testing piece, PARCC is going to be administered this year. In addition to reducing testing, it is a priority of the CTU to try to get legislation introduced and passed that will <u>NOT</u> allow the results to be used for any high stakes decisions. That is the PAUSE on PARCC for high stakes decisions.

These are 2 separate and very important issues and we need to be emphasizing both of these issues. Over-testing is already on the legislative radar. We need PARCC <u>not</u> being used for high-stakes decisions to also be on the legislative radar. Since legislators are already hearing from constituents and focusing on over testing – please help the CTU put PAUSE ON PARCC on the legislative agenda by emailing your State Senator.

#### LICENSE RENEWAL

Anyone that has a certificate that expires this year, should plan on turning in all renewal documents ASAP. Save the stress – don't wait until the last minute.

One change that began as of September 2014 – licenses will no longer be mailed as a hard copy. Once the license is issued, it will be emailed to the district and to the educator. ODE has noted that people with gmail accounts are having some problems, as the emails from ODE seem to go directly to SPAM or junk folder.

#### ODE WAIVING LICENSURE FEES FOR MILITARY

In January, the Ohio Department of Education announced it will waive teacher licensure fees for military members and their spouses. The agency said the fee waiver applies to all educator license applicants who are veterans, current service members or spouses of current members, as well as members of the National Guard or Reserves. The state has 45 different types of licenses, ranging from a teaching aide permit at \$25 for the license, to any professional license, which tends to cost about \$200. The applicants will have to provide their DD214 form that indicates they have military credentials.
